1 pCon.box

With pCon.box you can create a floorplan on location (e.g via a file from the customer or a photo from a floorplan) with the furniture you selected. Afterwards you can configure the selected furniture. It is also possible to create an article list. A desktop version of pCon.box is also available so that the customer can already experience the use of pCon.box.

General functionalities:

- Interactive and real-time product configuration
- Create a detailed article list.
- Sharing CAD files, images, product and price information.
- Create and manage your projects.
- Make a lasting impression with Augmented Reality.

1.1 System requirements for pCon.box App

Apple: iPhones, iPads (iPad Air ore higher, iPad mini 2 ore higher) and iPod Touch devices, operating system iOS 9.2 or later are supported.

Android: All devices with operating system 5.0 or higher are supported.

Note: Augmented Reality functions are available on devices that support AR. Check here if your device supports AR: https://developers.google.com/ar/discover/supported-devices

Windows: Tablets and p.c.'s with Windows 10 (64-bit) operating system are supported.

1.2 System requirements for pCon.box Website

To use pCon.box on a website, you need a browser that supports WebGL. Here you can test if your browser supports WebGL.

You can easily add products to your shopping cart. You can also create product pages and product comparison pages with different configurations and prices. The information includes all leaflets, photo material, product information and, for example, certificates/regulations. pCon.facts is available via phone/tablet. From pConfacts it is possible to make an offer of the furniture. Moreover, in this app you can use Augmented Reality (AR) to present the product in a room. This can only be done for 1 product at a time.General functionalities:

- Share photos, product and price information
